Chair in Corporate Governance

The Institute of Chartered Secretaries and Administrators (ICSA) has announced its joint sponsorship of a new Chair in Corporate Governance at Bournemouth University. This is the first position of its kind in the UK.

The considerable interest in corporate governance issues in recent years will be the major research focus for the new professor. This will include intensive research into the implementation of the Cadbury and Greenbury reports; business ethics; stakeholder theories; corporate democracy and accountability to shareholders; and the increasing level of statutory duties to which officers and directors are subject.

As well as examining the impact of corporate governance on commercial organisations, the ne appointee will be responsible for looking at the ways it also impinges on local and national government and 'not for profit' institutions.

VAT and Business

The Chairman of HM Customs and Excise, Valerie Strachan, believes that Customs and Excise has a frontline role in making VAT simpler for business. Speaking at the British Chambers of Commerce national conference she said:

"Our extensive programme has already produced hundreds of changes – large and small – all focussed on making business compliance more straightforward and less costly, and so helping competitiveness."

She highlighted the wide range of measures taken so far and their effect: from savings of £20m for the UK construction industry through streamlining legislation, to special partnerships with businesses competing from contracts in countries where new tax systems were being introduced.

The Chairman emphasised the scale of the Department's progress which involved:

- closer working with the Inland Revenue and Contributions Agency on over 40 projects;
- a radical restructure of internal processes into single systems – LEGIS;
- more reliance on audit checks at traders premises;
 and
- more advance information through business systems to help enforcement.
